This has been proven with success after success in winning numerous Social Security and SSI Disability cases – all while working with our very limited part time volunteer staff. Compassion In Action – USA (CIA) is now on the brink of having a full-time Executive Director, more volunteers and advocates, and completing the creation of our Disability Workshops, which will teach you how to duplicate our success!

Compassion in Action - USA has been sustained financially and emotionally by many people and we are thankful and grateful for the support that has been received. As CIA moves forward over the next 12 months we will continue to need your financial support. In a strong effort to be self-funded, scheduling of the Disability Workshops will begin in a few months. These will increase the number of disabled who will receive benefits that will sustain them while they are unable to work. In addition, CIA will receive income that will allow us to continue our work into the future, expanding into other counties in California and then nationally. Our vision is to change the outcome of Social Security Disability claims from a bleak 60-85% denied to 100% approval for those who are legitimately disabled. The waiting time for approval of claims will be cut from 4 years to a maximum of 6 months. Many claims may be approved even faster. The disabled in our country should not be homeless, hungry, and near death before they are helped!

One of the first calls Compassion In Action – USA (CIA) received was from a friend of the Conder Family. Jonathan Conder had been released from the hospital in January 2003, after a tragic auto accident seven months earlier involving a driver who was later charged with a DUI. Jonathan, a 21 year old student, had sustained Traumatic Brain Injury and would require long-term care for his permanent injuries. The Conders' private health insurance was exhausted quickly and Medi-Cal had been covering his care. Unfortunately, Med-Cal stopped coverage for his care when Jonathan was released fron the hospital. CIA stepped in and restored the Medi-Cal coverage and services were restored within a week.

Jonathan is a true hero. His website <a href="www.jconder.com">www.jconder.com</a> has the complete story, but we'll share a brief overview here: Jonathan came home to a hospital bed in his family's living room. Although he was unable to walk or feed himself, Jonathan did not give up. Jonathan has made great progress since Janury 2003. He now walks with a quad cane and has attended classes at Coastline Community College and High Hopes Head Injury Program in Tustin, CA. Jonathan proudly shared his high school graduation picture with Compassion In Action – USA President Barbara Case, and said his goal is to be that bright, healthy young man again. In our eyes he has surpassed that goal.
